Hello S.L.A.A. Friends!

We are now in 2026 and are celebrating S.L.A.A.'s 50th anniversary! Our Basic Text states that our first meeting was held on December 30, 1976, but our Founder, Rich, informed us that our first meeting was instead held on December 28, 1976.

We will be celebrating our 50th anniversary in several ways:

- We had a sale on existing stock of the State of Grace on the Fellowship-Wide Service bookstore for 50% off for the month of January 2026.
- For the first time since our 40th anniversary in 2016, there will be a 50th Anniversary International Recovery Convention. It will be held 21–23 August 2026. Not only will it be co-hosted by Greater Delaware Valley's and Ireland's Intergroups, but a hybrid option will also be available. More information will be forthcoming about this very fun event!
- The Board of Trustees (BOT) will hold a workshop titled "Growing Forward Together." It will be held on March 1, 2026, at 8:00 p.m. UTC (www.worldtimebuddy.com). Seven BOT members (this was organized before James joined the BOT) will lead a workshop in one of two time slots. Please see the flyer in this newsletter.

We appointed James B. (Utah) to the BOT. He was approved to be the chair of the Board Outreach Committee (BOC), second BOT member of the Board Technology Committee (BTC) and the BOT liaison to the Conference Translation and Intergroup Outreach Committee (CTIOC). Welcome, James!

Furthermore, Karma K. (CA) was approved to be one of our whistleblower investigators along with Kathleen A. (CA). Welcome, Karma! Many thanks to Seth S., who stepped down after completing almost three years as a whistleblower investigator.

You'll hear more about this from Pam, our executive director, but we approved Thursday–Sunday, 6–9 August 2026, as the 2026 Virtual ABC/M dates. As I mentioned in the last FWS Newsletter Edition, Greater Delaware Intergroup will be our host.

In case you haven't heard, our 2025 ABC/M minutes are complete and have been distributed to all 2025 ABC/M attendees.

Because of the work of our Treasurer, Jeff, and with the help of the Conference Finance Committee, we approved the financial statements for our last fiscal year, October 1, 2024,–September 30, 2025.

Starting in January 2026, BOT Regular and Interim monthly meetings will be held on the fourth Sunday of the month starting at 9:00 p.m. UTC. Starting on March 8, 2026, these meetings will instead start at 8:00 p.m. UTC for the rest of the 2025–2026 conference year.

The BOT approved additional compensation for our sensational full-time FWS team: Administrative Assistant Christina, Logistics Manager Hector, and Executive Director Pam. In case you have not seen this in past editions, the three of them have been working at FWS for over ten years, and not one of them is a Fellowship member.

BOARD DEVELOPMENT COMMITTEE

As always, I want to thank our 2025–2026 BDC members for their service:

Board of Trustees (BOT) members:

Non-Board members: Lisa S. (NJ, USA), Michelle N. (CA, USA)

The BDC recommended that James B. from Utah, USA, be forwarded to the Board of Trustees (BOT) to be considered for one of the two vacant BOT positions. The BOT approved his appointment. He was approved to be the chair of the Board Outreach Committee (BOC), a second BOT member of the Board Technology Committee (BTC) and the BOT liaison to the Conference Translation and Intergroup Outreach Committee (CTIOC). Now that we have eight positions filled, we continue to look for someone to fill the ninth and last BOT position.

Karma K. (CA) was approved to be one of our whistleblower investigators along with Kathleen A. (CA). Welcome, Karma! Many thanks to Seth S. who stepped down after completing almost three years as a whistleblower investigator.

In my last report, I stated that we recently started to update the BDC's mission statement. We completed the update as follows:

BDC Mission Statement (unanimously approved 16 December 2025):

- The BDC focuses on the internal activities, systems and procedures of the BOT to ensure its long-term effectiveness. Specifically, the committee:
- Determines the need for new trustees, identifies the necessary qualifications, and recruits candidates.
- Functions as a nominating committee by presenting candidates to the Conference or the BOT.
- Facilitates the nomination, appointment, and election of BOT members.
- Leads succession planning and addresses issues related to BOT terms of service.
- Identifies and helps develop Fellowship members with future service potential.
- Reviews the BOT's functions and effectiveness, and assists the BOT chair, as needed, to manage the annual BOT self-assessment process and strategic planning.
- Reviews bylaws, internal policies and procedures, then recommends amendments as necessary.
- Designs, updates, and oversees the new BOT member orientation, assisting new members in becoming fully integrated both functionally and socially.
- Reviews and updates BOT forms.
- Creates and organizes S.L.A.A. Archives.

We also plan to revise several outdated BOT forms. We are currently editing the Confidentiality and Non-Disclosure Agreement.

Frost operating accounts have been zero balance for almost a year. The bookkeeper has been directed to zero-out these three numbers.

Wells Fargo operating account: Average balance in August 2024 was \$12K-\$18K. Today we have in more than \$100K. Goal is \$150K to allow us to start paying back the Prudent Reserve.

PayPal is an active contribution portal, especially at the end of the calendar year. Balance is transferred at \$10K but stays at a minimum of \$3K in case of refunds.

2025 Vanguard Balance



The Prudent Reserve

- Our "rainy day fund"
- 3 years ago, it was over \$225K
- We borrowed \$50K to help pay for the last in-person ABM
- BFC's intention was to have this money paid back, eventually
- Organic interest growth in 2025 averaged \$663 per month
- At that rate, it would take 4 years to get back to \$225K
- BFC Plan is to repay the gap between the balance of the Vanguard account and \$225K once the operating account has reached \$150K

- October was the biggest Q1 month in both income and expenses (extra pay period and \$5K in insurance policies)

Contributions in Q1 = \$53K

- 46% of our \$116K gross income in Q1 came from contributions
- Stronger contributions in Q1 this year compared to last year (+16% YoY growth)
- Intergroups are 44% of the donations, skewed by the L.A. IG \$13K October donation
- **Without the outlier:** Intergroups are 23% of the adjusted total, while Individuals then are the leading donors at an adjusted 43%
- Note the two individuals in the top 5 donors in Q1

- \$23K sales in monthly merch/lit sales in first two months softened to \$13K in December

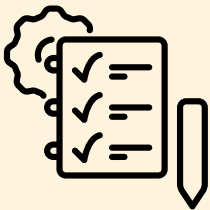
ABM Process Flow Charts, Procedures, and Quick Reference Visualizations

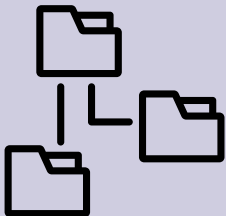

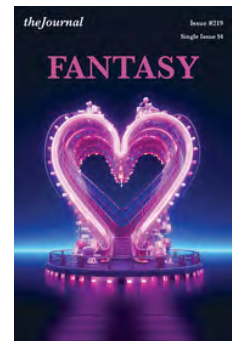

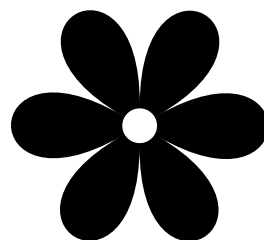

Guidelines and Deadlines for Submissions for the F.W.S. Newsletter

The following guidelines are helpful when submitting service articles, reports and flyers, for the F.W.S. Newsletter:

- The mission of the **F.W.S. Newsletter** is to publish items related to S.L.A.A. service and business: Conference and Conference Committees, F.W.S. Office, Board of Trustees, Board Committees, and relevant Intergroup events related to carrying the message. Minutes will not be accepted.
- Make submissions in a .doc or .docx file, with the exception of flyers created for specific events or requests. Submissions for all committee related flyers must be clearly dated eg. date/month/year, as to when they were created, approved by the relevant service body, or last revised, as applicable. The month must be written out, not numerical, such as 18 March 2025 or March 18, 2025. This helps readers see what is current and what isn't. Without a clear and visible date, submissions may not be accepted.
- Submissions should be portrait in orientation rather than landscape. The ideal size for submissions is letter (or A4).
- Please submit your item by the deadline for each edition, after the previous edition has been published. That is the only way the Newsletter editor will know that you wish the item to appear again and whether it has changed since its last appearance.
- Remember to maintain anonymity by using first name and last initial.
- Place periods between the initials in S.L.A.A., except when included in a specific website address such as slaafws.org or a specific email address such as slaavirtual@gmail.com.
- The Newsletter is not a recovery-oriented publication *per se* and not to be confused with *theJournal*, which publishes personal recovery stories.
- Members of the Board Outreach Committee (BOC) may respond by email to your Newsletter submission for edits as necessary and appropriate. This includes correcting typos, punctuation, breaking paragraphs correctly, editing for clarity, such as in sentence and paragraph structures and flow and any other usual editorial duties.
